## Summary of Modifications to SMART in July 2012 (13.9) Release Dates August 10, 2012

This table summarizes the major changes for users in July 2012 SMART Releases.

Several modules change in the new versions to provide greater functionality to the user, as summarized below.

Module Affected	Description		
Encounters	The treatment ID on the screen display of Encounters Notes (ENC ID) now matches the delivered service ID on the exported report of Encounters (found under Reports) which matches the ENC ID on the client profile portion of the Encounter.		
eCourt Admission	The "First Arrest" drop-down in the legal section of the eCourt admission was pre-populating to "yes." This field no longer pre-populates. Also, "N/A" was added as a value in the drop-down. The sort order for the values in the drop down is as follows: Yes, No, N/A. The addition of "N/A" is helpful for courts that are not criminal courts (such as Family Recovery Courts).		
Support Ticket	Many new rules were applied for the Support Ticket feature in SMART.		
Invoice Management	Added headers (Invoice File Number, Payor Adjudication Batch #, Agency Name, Address, Tax ID, Amount) and the invoice file number ID to the first column of the Excel file generated when a file is created. Also, modified email addresses that are used to send notifications when a file is created.		
<b>Client Outcome Measure</b>	Modified the Client Outcome measure so that there is only 1 Outcome Measure type and removed business rules requiring an admission or discharge.		
Admission (treatment)	Hide three fields on the Substance Abuse page of the treatment admission due to the addition of a page which gathers Tobacco use at admission. The following fields were hidden: Age when first used tobacco, Does client currently use tobacco, and Tobacco use in last thirty days. Some of these questions are covered in the new questions on the Tobacco page.		
<b>Reports (GPRA Interview Data</b>	Added "Military Family and Deployment" and "Violence and Trauma" values to the Excel report. This		
Report)	mirrors the values that are currently available in t he SAID download.		
Claims Reconciliation Report	Added "Invoice File ID" as a searchable parameter. Renamed the existing "invoice no" search parameter and report column to "Payor Adjudication Batch ID" to accurately reflect what the value is.		
Encounters	Added to ability to create encounter records without an admission, if there is at least one program enrollment where the program modality's "requires admission" flag is set to false. This will allow assessment and care coordination programs to enter encounters without requiring a treatment admission.		
<b>Consented Activity List</b>	Users can now view consented profiles, admissions, discharges and TAPs consistently with no issues.
