

Summary of Modifications to SMART in September 2013 Rev 4 (14.12.4) Release
Release Date October 25, 2013

This table summarizes the major changes for users in September 2013 SMART Release.

Several modules change in the new version to provide greater functionality to the user or to correct previous issues, as summarized below.

Module Affected	Description
Assessments/BHA	A new link "Add Addendum" has been added to the BHA screen. The Addendum link is active only if the Assessment is Active-Signed Off. On the Addendum screen, the Summary, Unsigned, and Signed boxes behave just as in a Misc. Note. The "Delete Addendum" link is available to users with WITS admin role. A menu item "Addendum" is added to the end of the BHA menu item list, it is visible only when the Addendum is added to BHA.
Collateral Contacts	When accessing collateral contacts from Intake, Admission, and Tx Team, clicking cancel now returns users to the screen that the user came from.
Client	Occurrences of the Unique Client Number with the label "Client ID" were re-labeled to "Unique Client Number. An informational message was added to the client search when no matches are found using the Client ID search parameter.
Admission	The error message "Months employed or in Voc/Ed Training in last 12 months must be less than or equal to 12." now appears when entering a number greater than 12.
ATR3 Intake	On the Intake screen, a new read-only field "Client ATR Funds Remaining" has been added for ATR3 intakes. This field will display the amount of money remaining before the client reaches the client-specific cap, if one exists, or the plan cap, if a client-specific cap does not exist. In HI, on the ATR intake, the field "Client ATR Funds Remaining" has been hidden as HI has special ATR set-up.
Reports	The following changes have been made to Admissions: Client Demographics report: 1. Made agency a required field to force the user to select one agency and remove the "All" option from the Agency list. 2. Now when the user chooses an agency, the facilities will be filtered based on the selected agency. Facilities will also be read-only if no agency is selected. 3. Made the required Facilities and Sub Reports parameters dark yellow (when not grayed-out) since they are required fields.
Domains	: Enabled ATR, Substance Abuse, Gambling and Mental Health domains in Maryland. Also created a new "DJS" domain. Completed a data migration to assign domains to existing Agencies, Intakes, Programs, Contracts, Services and Code Tables.
TAP Assessment	1) On the Client Profile page, the following read-only fields that are populated from elsewhere in the record now have a grey background: County of Residence, Military Status, Ethnicity, Race, Source of Referral, and Education. 2) On the Alcohol/Drug Usage page, if the Primary, Secondary, or Tertiary problem is changed from none to a substance, questions 2- 9 will be cleared. Also, the answer for question 9 cannot be a date in the future. 3) On the Support Sys: Legal page, an error message now occurs when question 22 is greater than question 21.

Module Affected	Description
GPRA follow up due report	: Setting the Follow-up Attendance parameter to "Non-Compliant" now again returns the proper results.
MD - Client Progress Report	: All section headers and column headers appear on the next page when there is a page break.
Assessments	Now, the DENS ASI Interviewer's Assessment text utilizes the entire width of the screen on Generate Report. For Printable View, user can control the text from getting cut off when printing by the Print Preview setting (Select Printable View - File - Print Preview) and adjusting the Shrink to Fit percentage.
Admission	The error message "Axis V / GAF Score must be less than or equal to 100." is now displaying when the "Highest GAF score in last year" field is higher than 100. Also, the error message "The Highest GAF Score in past 12 Months field is an invalid integer format." has been changed to "The Highest GAF Score in last year field is an invalid integer format."
Some Items Pertain Only to Department of Juvenile Services Users, as follows:	
Treatment Service Plan	Treatment Service Plan Sign Off and TSP Review functionality changes. Also, previously, when a user attempted to save a DJS Treatment Service Plan (DJS TSP) record when they did not originally create the DJS TSP, the system was only warning if the user clicked save on the DJS TSP profile page. The DJS TSP has been modified and the user will get the warning message "You are not the original author of this Treatment Service Plan, are you sure you want to save your changes to this plan?." on other pages of the DJS TSP as well.
