Summary of Modifications to SMART in March 2013 (14.6) Release Release Date March 29, 2013

This table summarizes the major changes for users in March 2013 SMART Release.

Several modules change in the new version to provide greater functionality to the user or to correct previous issues, as summarized below.

Module Affected	Description
Admission	The "Recommended Level of Care (ASAM)" and the "Controlled Environment (Scores)" are now always required for state reporting, regardless of the user's answer in the "Scores - Submit without scores" field. The Smoker Status and the First Tobacco Use Age field has been updated with user friendly names on the "Admission Progress Details" popup and the duplicate "ASI Controlled Env" (which appears in MD only) message has been removed. The School Attendance, Employment Status, Expected Payment Src, and Insurance Type fields on the Financial/Household screen were widened to accommodate lookup values having a large number of characters.
Authorization Request	An error no longer appears on approving PBA change requests for local vouchers.
Client Group Enrollment	Fixed an issue where the Government Contract Start Date would not accept a date in the mmddyy format.
Consent/Referral	Filtered inactive agencies out of the available selections in the "Disclosed To Agency" field on the Consent screen and the "Refer To Agency" field on the Referral screen. An "inactive" agency is an agency where the Start Date is <= today's date or the Inactive Date is >= today's date.

Module Affected	Description
Continuing Care Checkup	If the Result field is set to "Client not found" or "Client Refused", all of the fields on the checkup are read only except the following: date, result, staff, start time, end time and schedule next contact date and time. Additionally, modified state reporting requirements such that if either of these values are selected, the record will be considered complete.
Drug Test Results	Updated the existing PDF Report to match the new format of Drug Test Results section in the Client Progress Report and replaced the "Agency" column with "Specimen #". A Finish button, which when clicked brings the user back to the Client Activity List, has been added to the Drug Test Results List screen as well as the MD-only Drug Test Appointments screen. Additionally for the MD-only Drug Test Appointments screen, clicking "enter' will now execute the search.
eCourt	The "Generate Report" link on the PS Court - Community Service screen has been removed.
Encounter	Error message on the encounter screen has been updated to include that the military time format is acceptable in the start time and end time fields.
GPRA	Changed the hover text for all GPRA fields to match the screen label rather than the database name.
Payor Claim History	The HTML line break tag () no longer appears in any of the export column headers.

Module Affected	Description
Program	The "Days on Waitlist" field is no longer required for state reporting.
Enrollment	Previously, the system was displaying the error message "After the first Program Enrollment, you must use the action link at the bottom of the TEDS/NOMs fields to enroll the client in another TEDS program." at improper times. Now, this message only displays if the user is attempting to enroll in another program without utilizing the "Enroll in Concurrent Level of Care" link. The "Pregnant at Enrollment" field in the TEDS/NOMS Status at Program Enrollment section of the Program Enrollment Profile screen will now always be populated by the value from the "Pregnant" field on the Intake screen.
Referral	When reviewing a placed/accepted referral in the activity list of the Referred By agency the Referred To Program field is now read-only.
Reports	A yellow screen no longer occurs when running the 'CSAT Monthly Report – New' for any date parameters.
ТАР	Previously, in sections that have the Past 30 days and the Lifetime fields, when the page refreshed or saved certain answers in the Past 30 days field would clear themselves. This issue has been fixed. The problem is illustrated with the following example: when the Question 8 Lifetime field is set to NO and the Question 9 Lifetime field is set to YES, any value subsequently selected for the Question 9 Past 30 Days was being cleared. This has been resolved so that all answers will be retained if the page refreshes.
Voucher	Users with Authorization Full Access are now allowed to Reopen Vouchers even if the Agency did not create the Voucher, as long as the agency has the right key activities.
Voucher List	The dollar amounts shown on the Authorized, Encumbered, Expended, and Available now have the same decimal place formatting.
